#### NOTICE OF ANNUAL GENERAL MEETING

**Notice is hereby given** that the Annual General Meeting of **Alset International Limited** (the "**Company**") will be held at 138 Cecil Street #01-02 Cecil Court, Singapore 069538 on Wednesday, 30 April 2025 at 10.30 a.m. (Singapore Time) for the following purposes:

## **As Ordinary Business**

- 1. To receive and adopt the Directors' Statement and the Audited Financial Statements of the Company for the financial year ended 31 December 2024 together with the Auditors' Report thereon. (Ordinary Resolution 1)
- 2. To approve the payment of Directors' fees of up to \$\$200,000 and for payment of such Directors' fees half yearly in arrears for the financial year ending 31 December 2025 (2024: \$\$200,000).

  (Ordinary Resolution 2)
- 3. To re-appoint Foo Kon Tan LLP as the Company's Auditors for the financial year ending 31 December 2025 and to authorise the Directors of the Company to fix their remuneration.

  (Ordinary Resolution 3)
- 4. To re-elect Mr. Chan Heng Fai, who is retiring by rotation pursuant to Regulation 89 of the Company's Constitution, and who, being eligible, offers himself for re-election, as a Director of the Company.

- 5. To re-elect Mr. Wong Tat Keung, who is retiring pursuant to Regulation 89 of the Company's Constitution, and who, being eligible, offers himself for re-election, as a Director of the Company. [See Explanatory Note (ii)] (Ordinary Resolution 5)
- 6. To note the retirement of Mr. Lui Wai Leung Alan, who is retiring pursuant to Regulation 89 of the Company's Constitution.
- 7. To transact any other ordinary business which may properly be transacted at an Annual General Meeting.

# **As Special Business**

To consider and if thought fit, to pass the following resolutions as Ordinary Resolutions, with or without any modifications:

8. Authority to allot and issue shares in the capital of the Company - Share Issue Mandate

That, pursuant to Section 161 of the Companies Act 1967 (the "**Companies Act**") and Rule 806 of the Catalist Rules, authority be and is hereby given to the Directors of the Company to:

- (a) (i) allot and issue new shares in the capital of the Company ("**Shares**") (whether by way of rights, bonus or otherwise); and/or
  - (ii) make or grant offers, agreements or options (collectively, "**Instruments**") that might or would require the Shares to be allotted and issued, including but not limited to

the creation, allotment and issue of (as well as adjustments to) options, warrants, debentures or other instruments convertible into Shares,

at any time and upon such terms and conditions and for such purposes and to such persons as the Directors of the Company may in their absolute discretion deem fit; and

(b) notwithstanding that the authority conferred by this Resolution may have ceased to be in force, allot and issue Shares in pursuance of any Instrument made or granted by the Directors of the Company while this Resolution is in force,

### provided that:

- (1) the aggregate number of new Shares (including Shares to be allotted and issued in pursuance of the Instruments made or granted pursuant to this Resolution) to be allotted and issued pursuant to this Resolution shall not exceed one hundred per cent. (100%) of the total number of issued Shares (excluding treasury shares and subsidiary holdings) in the capital of the Company (as calculated in accordance with sub-paragraph (2) below), of which the aggregate number of new Shares to be allotted and issued of in pursuance of Instruments made or granted pursuant to this Resolution) does not exceed fifty per cent (50%) of the total number of issued Shares (excluding treasury shares and subsidiary holdings) in the capital of the Company (calculated in accordance with sub-paragraph (2) below);
- (2) subject to such calculation as may be prescribed by the SGX-ST, for the purpose of determining the aggregate number of new Shares that may be allotted and issued under sub-paragraph (1) above, the percentage total number of issued Shares (excluding treasury shares and subsidiary holdings) in the capital of the Company shall be based on the total number of issued Shares (excluding treasury shares and subsidiary holdings) in the capital of the Company at the time of the passing of this Resolution, after adjusting for:
  - (i) new Shares arising from the conversion or exercise of any Instruments or any convertible securities;
  - (ii) new Shares arising from exercising of share options or vesting of share awards, provided that the share options or the share awards are granted in compliance with Part VIII of Chapter 8 of the Catalist Rules; and
  - (iii) any subsequent bonus issue, consolidation or sub-division of Shares;

Any adjustments made in accordance with sub-paragraphs 2(i) or (2)(ii) above shall only be made in respect of new Shares arising from convertible securities and Instruments which were issued and outstanding and/or subsisting at the time of passing this Resolution.

- in exercising the authority conferred by this Resolution, the Company shall comply with the provisions of the Catalist Rules for the time being in force (unless such compliance has been waived by the SGX-ST) and the Company's Constitution for the time being; and
- (4) unless revoked or varied by the Company in a general meeting, such authority conferred by this Resolution shall continue in force until the conclusion of the next Annual General Meeting of the Company or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is the earlier.

9. Authority to offer and grant share options and to allot and issue Shares in accordance with the 2024 Alset International Limited Share Option Scheme

That the Directors of the Company be and are hereby authorized to offer and grant share options in accordance with the 2024 Alset International Limited Share Option Scheme adopted on 30 April 2024 (the "**Option Scheme**") and to allot and issue such Shares as may be required to be

allotted and issued pursuant to the exercise of the share options under the Option Scheme, provided always that the aggregate number of Shares to be allotted and issued pursuant to the Option Scheme, the Share Plan (as defined in Ordinary Resolution 8 below) and any other share based incentive schemes of the Company shall not exceed twenty per cent. (20%) of the total number of issued Shares (excluding treasury shares and subsidiary holdings) in the capital of the Company on the day immediately preceding the relevant date of grant of options under the Option Scheme (or such other limit as the SGX-ST may determine from time to time).

10. Authority to offer and grant share awards and to allot and issue Shares in accordance with the 2024 Alset International Limited Performance Share Plan

That the Directors of the Company be and are hereby authorized to offer and grant share awards in accordance with the 2024 Alset International Limited Performance Share Plan adopted on 30 April 2024 (the "**Share Plan**") and to allot and issue such Shares as may be required to be allotted and issued under the Share Plan, provided always that the aggregate number of Shares to be allotted and issued pursuant to the Share Plan, the Option Scheme and any other share based incentive schemes of the Company shall not exceed twenty per cent. (20%) of the total issued Shares (excluding treasury shares and subsidiary holdings) in the capital of the Company on the day immediately preceding the relevant date of grant of awards under the Share Plan (or such other limit as the SGX-ST may determine from time to time).

- (i) Mr. Chan Heng Fai, if re-elected as a Director of the Company, will remain as the Executive Chairman, Executive Director and the Chief Executive Officer of the Company and a member of the Nominating Committee. Further information relating to Mr. Chan Heng Fai as required under Rule 720(5) of Section B: Rules of Catalist of the Listing Manual of the Singapore Exchange Securities Trading Limited (the "SGX-ST") ("Catalist Rules") in relation to his reelection may be found under the sections entitled "Board of Directors", "Corporate Governance Report" and "Additional Information on Directors seeking re-election" in the Annual Report for the financial year ended 31 December 2024 (the "FY2024 Annual Report").
- (ii) Mr. Wong Tat Keung, if re-elected as a Director of the Company, will remain as an Independent Non-Executive Director of the Company, the Chairman of the Nominating Committee, and a member of the Audit and Risk Management Committee and the Renumeration Committee. Mr. Wong Tat Keung is considered independent for the purposes of Rule 704(7) of the Catalist Rules. - (iii) The Ordinary Resolution 6 proposed in item 8 above, if passed, will empower the Directors of the Company from the date of the passing of Ordinary Resolution 6 until the date of the next Annual General Meeting or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is the earlier, to allot and issue new Shares, make or grant Instruments convertible into Shares and to issue Shares pursuant to such Instruments. The aggregate number of new Shares (including Shares to be allotted and issued in pursuance of the Instruments made or granted pursuant to Ordinary Resolution 6) to be allotted and issued pursuant to Ordinary Resolution 6 shall not exceed 100% of the total number of issued Shares excluding treasury shares and subsidiary holdings of the Company as at the date of the passing of Ordinary Resolution 6. For the allotment and issue of new Shares other than on a pro-rata basis to existing members of the Company, the aggregate number of new Shares (including Shares to be allotted and issued in pursuance of the Instruments made or granted pursuant to Ordinary Resolution 6) to be allotted and issued pursuant to Ordinary Resolution 6 shall not exceed 50% of the total number of issued Shares excluding treasury shares and subsidiary holdings of the Company as at the date of the passing of Ordinary Resolution 6. This authority will, unless previously revoked or varied by the Company in general meeting, expire at the next Annual General Meeting or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is the earlier.
- (iv) The Ordinary Resolution 7 proposed in item 9 above, if passed, will empower the Directors of the Company, to offer and grant share options and to allot and issue such Shares as may be required to be allotted and issued pursuant to the exercise of the share options under the Option Scheme.
- (v) The Ordinary Resolution 8 proposed in item 10 above, if passed, will empower the Directors of the Company, to offer and grant share awards and to allot and issue such Shares as may be required to be allotted and issued under the Share Plan.
